19/004 **Public Participation:** Chair of Village Hall was present regarding agenda item 19/008 and she explained that the Village Hall was updating the Village Hall Conveyance and Trust Deed of 1 January 1969 including personnel and village organisations. She sought confirmation that under the Second Schedule, the Parish Council would like to continue to nominate someone to serve as a Trustee of the Village Hall Charity. The Clerk reported on advice from Cambridgeshire ACRE regarding the roles and responsibilities of the Trustee and the relationship with the Council.

Chair of Village Hall was thanked for attending and she left at 7.45pm

19/005 **Minutes of the meeting** of 3 December 2018 had been circulated, were confirmed as a true record and signed by the Chairman, and agenda of same date signed by Chairman as confirmation of the business transacted at that meeting. Proposed K Mackender, seconded Chairman, and resolved unanimously.

19/006 Matters Arising

Clerk advised that the notices for invitation to quote for grasscutting and village maintenanchad been published. No local interest and invites had been issued to contractors.

K Mackender suggested a letter of thanks be sent to J & JA Construction.

19/007 REPORTS FROM DISTRICT AND COUNTY COUNCIL REPRESENTATIVES

Reports from County and District Councillors, previously circulated, were noted.

The meeting was opened and County Councillor Dupre said there was nothing to add since her report was published.

District Councillor M Bradley gave a verbal report and speedwatch statistics were noted. The proposed new flashing speed signs were discussed but there was still no guidance on those which met compliance for the Police. An application for support could be made to the County Council under the Local Highway Improvement Initiative (10% or more financial contribution required from Parish Council), or Third Party scheme, (full cost

borne by Parish Council – approx. £3000) but administrative assistance provided by County Council with purchase etc, or the Council could purchase direct from a supplier and liaise with County Council, Police etc to agree locations, requirements for moving etc. Noted the signs had to be mobile, operated by battery. Consents would be needed to use lamp posts to mount the equipment on.

District Councillor M Bradley reported that the Combined Authority was to purchase land on the old Princess of Wales site to make 92 more houses available, including 15 shared ownership community land trust home.

The District and County Councillor left at 8.07pm and the meeting was closed to the public.

19/008 VILLAGE HALL CONVEYANCE AND TRUST DEED

The proposals had been previously circulated to Councillors and advice sought from Cambridgeshire ACRE by the Clerk. Further information had been presented at the public participation period above.

Resolved that the Parish Council would wish to nominate someone to serve as a Trustee on the Village Hall Charity.

Clerk to advise Chair of Village Hall so that they could make the necessary arrangements to up-date the Conveyance and Trust Deed of 1969 regarding Trusteeship.

19/01024/FUL The Bungalow, Hive Road, Construction of office building on the site of a former pole barn – reduced footprint – external appearance changes.

Resolved that all the Parish Council's earlier comments on the application still stood, with particular reference to concerns regarding point 1 – Vehicular access – there is not a proper road from Hive Road; point 4 - environmental impact on nearby wetlands habitat; point 5 - outside the village development envelope for residential and business developments; and point 6 - that should the planning authority decide to approve the application a restriction should be imposed to ensure the site is for small business use only and no further expansion or change of use, including that the building to never become a habitable dwelling. Poor Condition of Droves: Noted that a number of issues regarding vegetation encroachment and ruts etc had been reported on many of the public rights of way in the parish on the County Council's 'Report It' system since July 2018 by members of the public. 19/012 CEMETERY MANAGEMENT

Condition of lychgate had been previously reported to Councillors (Burial Board) and Clerk had contacted a number of carpenter/joiners to discuss and obtain quotes for repairs/replacement of the posts and braces. There had been a delay in getting 3 quotes due to Christmas/New Year closure of the trade. ECDC had been contacted about grants and this was being followed up by the District Councillor. Metal braces had been installed as an interim measure. Clerk had so far been unable to source a suitable ready made small noticeboard as discussed at previous meeting and Council would need to consider getting one made.

Resolved that arrangements for replacement/repairs of the lychgate be deferred pending receipt of further quotes and advice, including information for grants.
